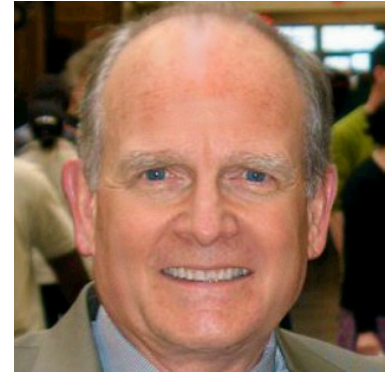

MY PERSPECTIVE

Utilitarian biomarkers for brain function, similar to cholesterol or blood lipids in medicine, continue to offer new diagnostic and treatment opportunities for the evolution of precise mind-care. Improved perspectives diminish guesswork and reductionistic thinking based upon superficial behavioral appearances and inadequate labels.

Valuable, increasingly available and cost effective data on such topics as the molecular physiology of synaptic neurotransmitter activity, neurotransmitters, immune challenges, hormones, trace elements and heavy metals provide fresh biomedical data points. These incredibly improved assessment tools encourage predictable progress with psychiatric treatment.

The global public actively seeks enhanced, more comprehensive and accurate, biomedical assessment tools for updated, data driven interventions. Applied biomedically relevant data will encourage that imperative evolution.

“ADHD” RELEVANCE

Neuroscience lessons learned in the disappointing context of highly prevalent and often misunderstood behavioral diagnostic conditions such “ADHD” will ultimately change the way psychiatric care is rendered across the entire spectrum of unbalanced brain functions.

Current ADHD treatment objectives target superficial behavior and ignore the underlying neuroscience, the functional foundation of ADHD difficulties. It’s now axiomatic: Too many treat thinking without thinking about thinking.

We must collectively move beyond the current helpful but insufficient diagnostic coding system based almost entirely upon those superficial, reductionistic and imprecise behavioral appearances. Inaccurate targets create ineffective treatment strategies based upon unreliable criteria.
